Any additional information required for evaluation shall be furnished upon request. The decision made in the discretion of the said Office shall be binding upon all interested parties.

The following list covers some, but not necessarily all, of the applicable ctions which are hereby imposed:		
	A.	There shall be no use or promotion of alcoholic beverages, tobacco products, or controlled substances on the campus of the University. Meat or meat products shall not be sold, promoted, or served on the campus.		
	B.	There shall be no use of vulgar or abusive language.		
	C.	The program shall not be political in nature.		
	D.	The primary purpose of the event shall not be fund raising. An offering may be taker to help cover the cost of the event, but a general appeal for funds to support the overall operation of the user organization shall not be made.		
	E.	No secular program (or preparation therefore or cleanup thereafter) shall take place between one-half hour before sunset on Friday and one-half hour after sunset on Saturday.		
	F.	Conduct and appearance of participants and attendees shall be appropriate to the approved purpose stated above. Any participants or attendees who do not reasonably conform to this requirement may be asked to leave the campus of the University.		
	G.	Meat or meat products shall not be sold or promoted on the campus.
